## 6. Beam Calculations

Determine reference design values, sectional properties and self weight of beam:

$$A = b \times d$$

$$S_x = \frac{bd^2}{6}, S_y = \frac{b^2d}{6}$$

$$I_x = \frac{bd^3}{12}, I_y = \frac{b^3d}{12}$$

where:

b = Breadth of rectangular beam in bending (in.)

d = Depth of rectangular beam in bending (in.)

A = Cross sectional area of beam (in.<sup>2</sup>)

S<sub>x</sub> = Section modulus about the X-X axis (in.<sup>3</sup>)

S<sub>y</sub> = Section modulus about the Y-Y axis (in.<sup>3</sup>)

I<sub>x</sub> = Moment of inertia about the X-X axis (in.<sup>4</sup>)

I<sub>y</sub> = Moment of inertia about the Y-Y axis (in.<sup>4</sup>)

$$b = 1.500 \text{ in.}$$

$$d = 5.500 \text{ in.}$$

$$A = 1.500 \times 5.500 = 8.25 \text{ in.}^2$$

$$S_x = (1.500)(5.500)^2/6 = 7.56 \text{ in.}^3$$

$$S_y = (1.500)^2(5.500)/6 = 2.06 \text{ in.}^3$$

$$I_x = (1.500)(5.500)^3/12 = 20.80 \text{ in.}^4$$

$$I_y = (1.500)^3(5.500)/12 = 1.55 \text{ in.}^4$$

where:

ρ<sub>w</sub> = Density of wood (lbs/ft<sup>3</sup>)

G = Specific gravity of wood (dimensionless)

m.c. = Moisture content of wood (percentile)

$$G = 0.55$$

$$m.c. = 28 \% \text{ (Estimated moisture content at wet service conditions)}$$

$$\rho_w = 62.4 \left[ \frac{0.55}{1 + 0.55(0.009)(28)} \right] \left[ 1 + \frac{28}{100} \right] = 38.58 \text{ lbs/ft}^3$$

$$\text{Volume}_{\text{total}} = N[A \times (L + l_b)] = 1 \times [8.25 \times (82.50 + 1.5)] \times (12 \text{ in./ft.})^3 = 0.40 \text{ ft}^3$$

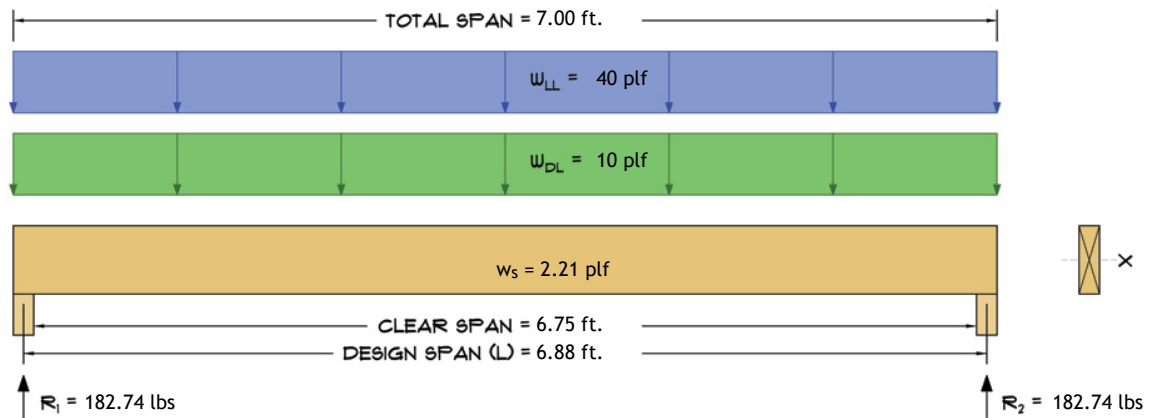
$$\text{Volume}_{\text{span}} = N[A \times L] = 1 \times [8.25 \times 82.50] \times (12 \text{ in./ft.})^3 = 0.39 \text{ ft}^3$$

$$\text{Total Weight (} W_T) = \rho_w \times \text{Volume}_{\text{total}} = 38.58 \times 0.40 = 15.5 \text{ lbs}$$

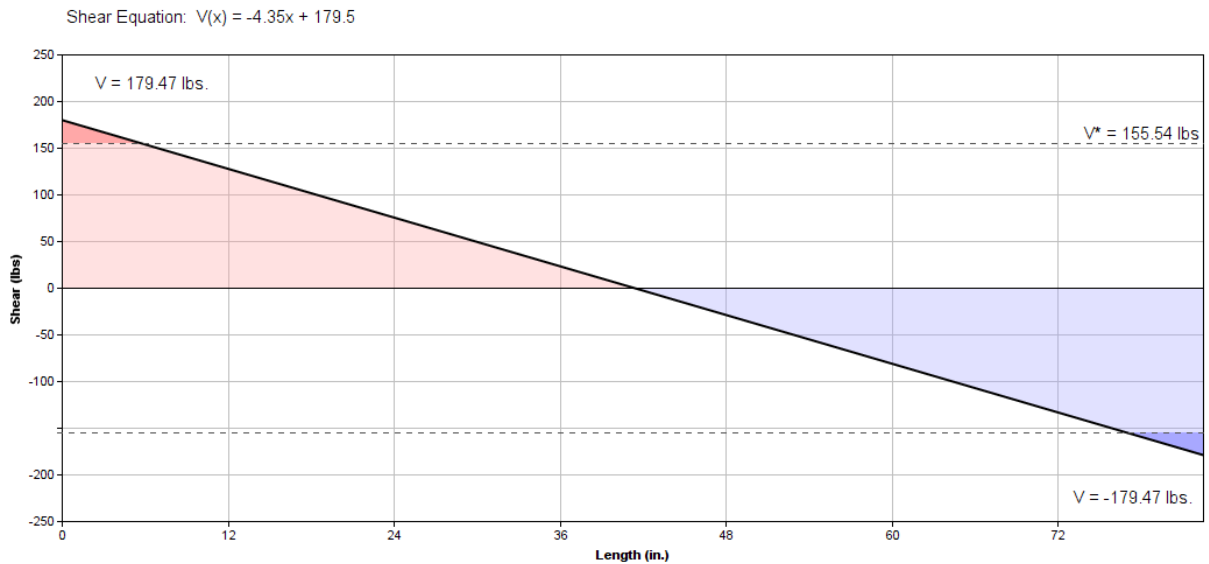
$$\text{Self Weight (} W_S) = \rho_w \times \text{Volume}_{\text{span}} = 38.58 \times 0.39 = 15.2 \text{ lbs}$$

$$\text{Distributed Self Weight (} w_s) = \frac{W_S}{L} = \frac{15.2}{6.88} = 2.21 \text{ plf}$$

**Beam - Shear Diagram**

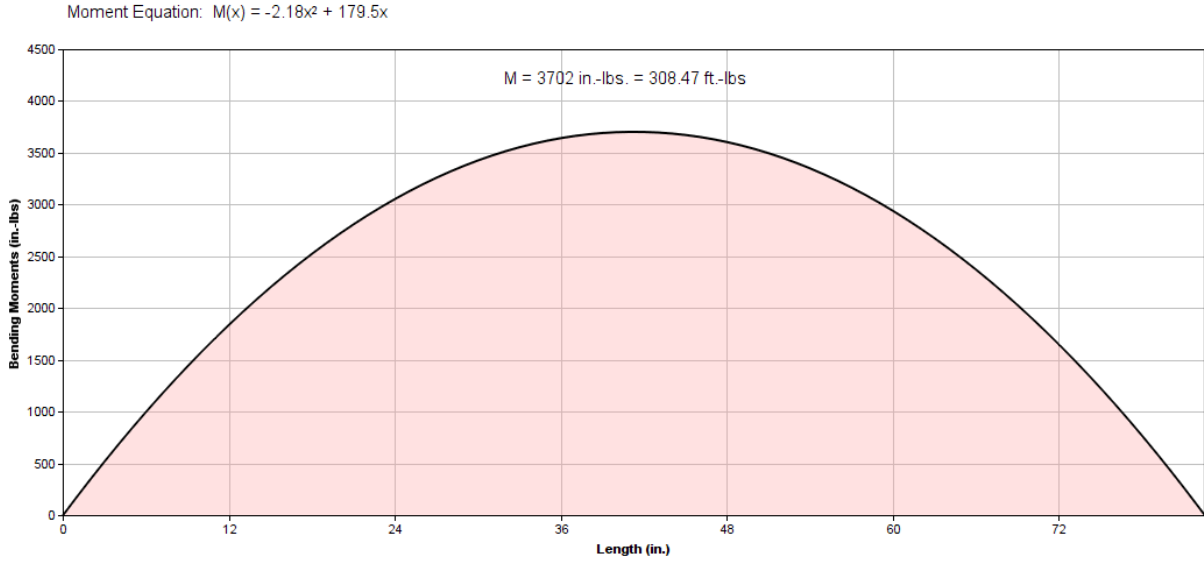

1.) Bending:

Members subject to bending stresses shall be proportioned so that the actual bending stress or moment shall not exceed the adjusted bending design value:

$$f_b \leq F_b' \text{ (NDS Sec. 3.3.1)}$$

where:

$$f_b = M / S$$

$$F_b' = F_b(C_D)(C_M)(C_t)(C_L)(C_F)(C_i)(C_r)$$

Beam is braced laterally along its compression edge. Lateral stability is not a consideration:

$$C_L = \text{Beam Stability Factor} = 1.0$$

$$F_{bx}' = (1000)(1.00)(1)(0.7)(1)(1)(1)(1) = 700.0 \text{ psi}$$

$$f_b = \frac{M}{N \times S_x} = \frac{3702}{1 \times 7.56} = 489.5 \text{ psi}$$

$$f_b = 489.5 \text{ psi} < F_{bx}' = 700.0 \text{ psi} \text{ (CSI} = 0.70) \text{ ? OK}$$

## 2.) Shear:

Members subject to shear stresses shall be proportioned so that the actual shear stress parallel to grain or shear force at any cross section of the bending member shall not exceed the adjusted shear design value:

$$f_v \leq F_v' \text{ (NDS Sec. 3.4.1)}$$

where:

$$f_v = \frac{3V}{2A}$$

$$F_v' = F_v(C_D)(C_M)(C_t)(C_i)$$

$$F_{vx}' = (175)(1.00)(0.97)(0.7)(1) = 118.82 \text{ psi}$$

Shear Reduction: For beams supported by full bearing on one surface and loads applied to the opposite surface, uniformly distributed loads within a distance,  $d$ , from supports equal to the depth of the bending member shall be permitted to be ignored. For beams supported by full bearing on one surface and loads applied to the opposite surface, concentrated loads within a distance equal to the depth of the bending member from supports shall be permitted to be multiplied by  $x/d$  where  $x$  is the distance from the beam support face to the load. See NDS 2015, Figure 3C.

$$f_v^* = \frac{3V^*}{2(N \times A)} = \frac{3(155.54)}{2(1 \times 8.25)} = 28.28 \text{ psi}$$

$$f_v^* = 28.28 \text{ psi} < F_{vx}' = 118.82 \text{ psi} \text{ (CSI} = 0.24) \text{ ? OK}$$

No Reduction in Shear (conservative):

$$f_v = \frac{3V}{2(N \times A)} = \frac{3(179.47)}{2(1 \times 8.25)} = 32.63 \text{ psi}$$

$$f_v = 32.63 \text{ psi} < F_{vx}' = 118.82 \text{ psi} \text{ (CSI} = 0.27) \text{ ? OK}$$

## 3.) Deflection:

Bending deflections calculated per standard method of engineering mechanics for live load and total load:

LL Allowable:  $L/180$

TL Allowable:  $L/120$

$$E_x' = E_x(C_M)(C_t)(C_i) = 1400000(0.9)(0.9)(1) = 1134000 \text{ psi}$$

$$\Delta_{LL} = \frac{5w_{LL}L^4}{384E'_x(N \times I_x)} = \frac{5(40)(6.875)^4}{384(1134000)(1 \times 20.80)} \times \left(12 \frac{\text{in.}}{\text{ft.}}\right)^3 = 0.09 \text{ in.}$$

$$(L/d)_{LL} = 82.50 / 0.09 = 968$$

$$\Delta_{LL} = 0.09 \text{ in} = L/968 < L/180 \quad ? \quad \mathbf{OK}$$

$$\Delta_{TL} = \frac{5(w_{TL} + w_s)L^4}{384E'_x(N \times I_x)} = \frac{5(50 + 2.21)(6.875)^4}{384(1134000)(1 \times 20.80)} \times \left(12 \frac{\text{in.}}{\text{ft.}}\right)^3 = 0.11 \text{ in.}$$

$$(L/d)_{TL} = 82.50 / 0.11 = 741$$

$$\Delta_{TL} = 0.11 \text{ in} = L/741 < L/120 \quad ? \quad \mathbf{OK}$$

#### 4.) Bearing:

Members subject to bearing stresses perpendicular to the grain shall be proportioned so that the actual compressive stress perpendicular to grain shall be based on the net bearing area and shall not exceed the adjusted compression design value perpendicular to grain:

$$f_{c \perp} \leq F_{c \perp}' \quad (\text{NDS Sec. 3.10.2})$$

where:

$$f_{c \perp} = \frac{R}{A_b}$$

$$F_{c \perp}' = F_{c \perp} (C_M)(C_t)(C_i)$$

$$F_{c \perp x}' = (565)(0.67)(0.7)(1) = 264.99 \text{ psi}$$

$$A_b = b \times l_b = 1.5 \times 1.5 = 2.25 \text{ in}^2$$

$$f_{c \perp} = \frac{R}{N \times A_b} = \frac{182.74}{1 \times 2.25} = 81.2 \text{ psi}$$

$$f_{c \perp} = 81.2 \text{ psi} < F_{c \perp x}' = 264.99 \text{ psi} \quad (\text{CSI} = 0.31) \quad ? \quad \mathbf{OK}$$
