6. Beam Calculations

Determine reference design values, sectional properties and self weight of beam:

$$A = b \times d$$

$$S_x = \frac{bd^2}{6}, S_y = \frac{b^2d}{6}$$

$$I_x = \frac{bd^3}{12}, I_y = \frac{b^3d}{12}$$

where:

b = Breadth of rectangular beam in bending (in.)

d = Depth of rectangular beam in bending (in.)

A = Cross sectional area of beam (in.²)

S_x = Section modulus about the X-X axis (in.³)

S_y = Section modulus about the Y-Y axis (in.³)

I_x = Moment of inertia about the X-X axis (in.⁴)

I_y = Moment of inertia about the Y-Y axis (in.⁴)

$$b = 1.500 \text{ in.}$$

$$d = 11.250 \text{ in.}$$

$$A = 1.500 \times 11.250 = 16.88 \text{ in.}^2$$

$$S_x = (1.500)(11.250)^2/6 = 31.64 \text{ in.}^3$$

$$S_y = (1.500)^2(11.250)/6 = 4.22 \text{ in.}^3$$

$$I_x = (1.500)(11.250)^3/12 = 177.98 \text{ in.}^4$$

where:

ρ_w = Density of wood (lbs/ft³)

G = Specific gravity of wood (dimensionless)

m.c. = Moisture content of wood (percentile)

$$G = 0.5$$

$$m.c. = 19 \% \text{ (Max. moisture content at dry service conditions)}$$

$$\rho_w = 62.4 \left[\frac{0.5}{1 + 0.5(0.009)(19)} \right] \left[1 + \frac{19}{100} \right] = 34.20 \text{ lbs/ft}^3$$

$$\text{Volume}_{\text{total}} = N[A \times (L + l_b)] = 2 \times [16.88 \times (95.50 + 3.5)] \times (12 \text{ in./ft.})^3 = 1.93 \text{ ft}^3$$

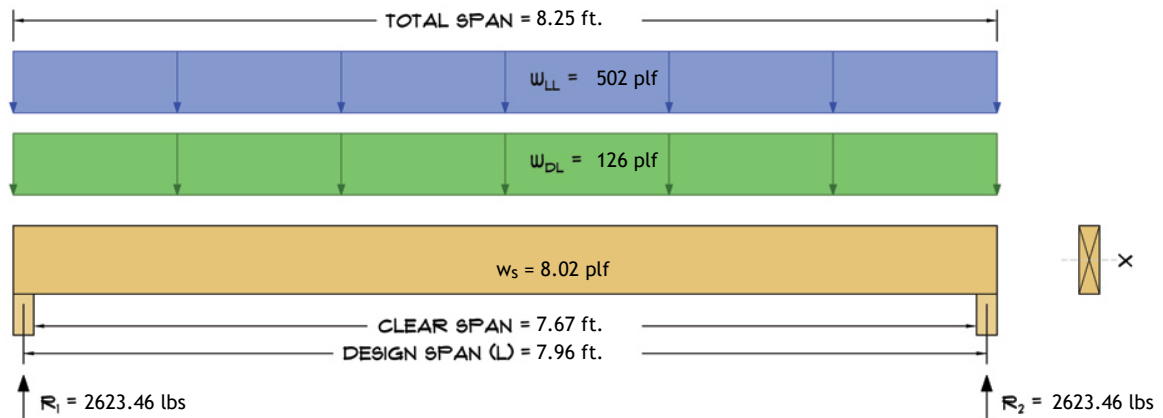
$$\text{Volume}_{\text{span}} = N[A \times L] = 2 \times [16.88 \times 95.50] \times (12 \text{ in./ft.})^3 = 1.87 \text{ ft}^3$$

$$\text{Total Weight (} W_T) = \rho_w \times \text{Volume}_{\text{total}} = 34.20 \times 1.93 = 66.1 \text{ lbs}$$

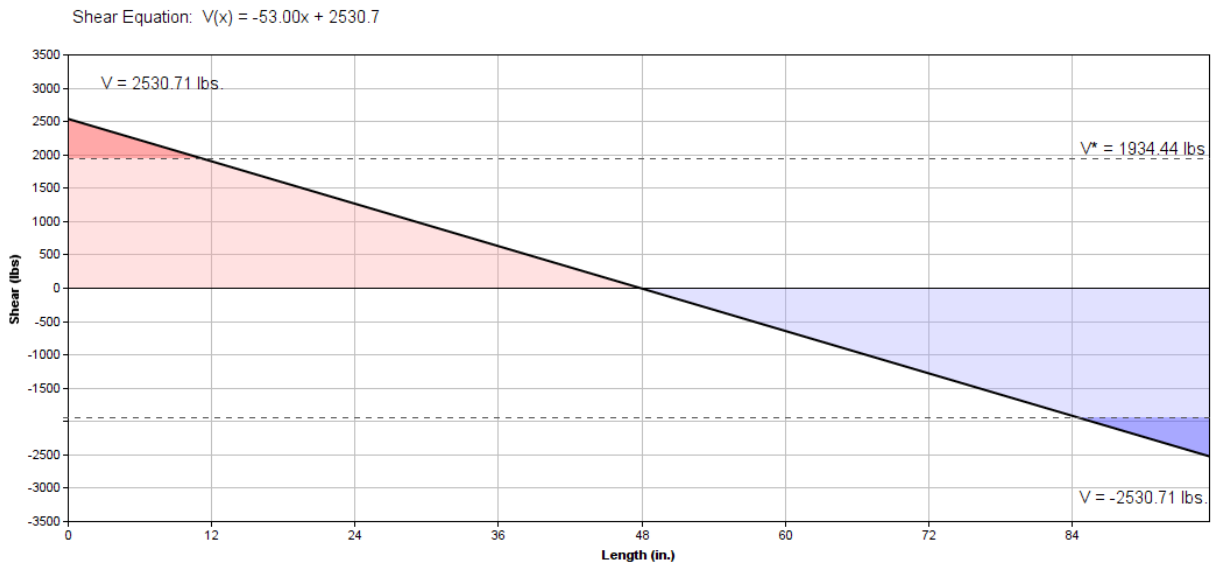

Beam - Shear Diagram



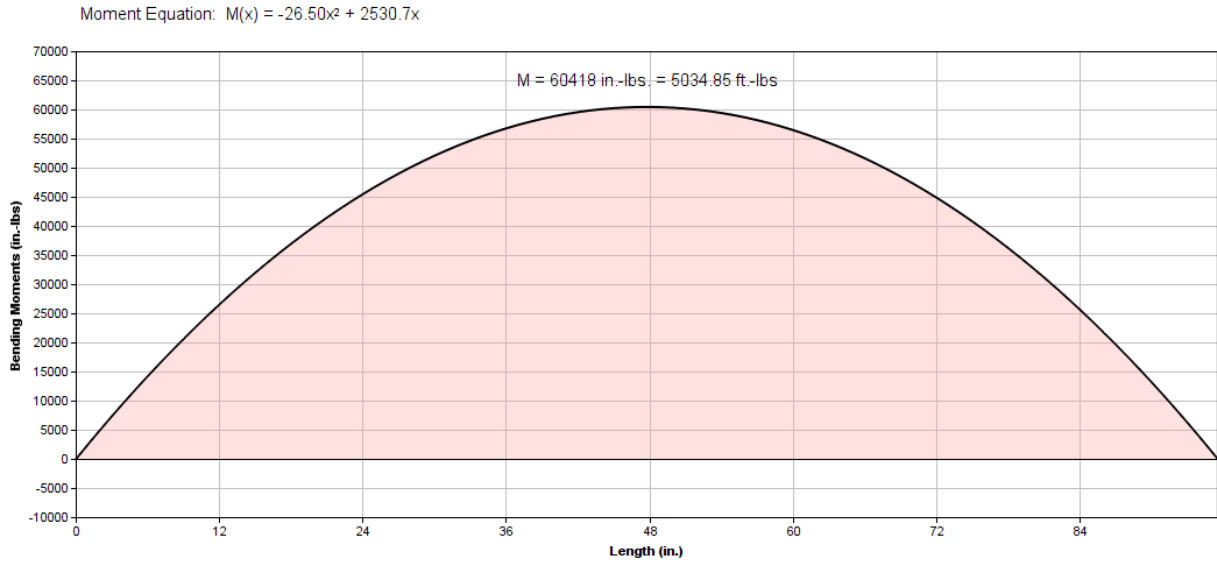

1.) Bending:

Members subject to bending stresses shall be proportioned so that the actual bending stress or moment shall not exceed the adjusted bending design value:

$$f_b \leq F_b' \quad (\text{NDS Sec. 3.3.1})$$

where:

$$f_b = M / S$$

$$F_b' = F_b(C_D)(C_M)(C_t)(C_L)(C_F)(C_i)(C_r)$$

Beam is unbraced along its compression edge, lateral stability is considered below:

Slenderness Ratio for bending member RB:

$$l_u = \text{Unbraced Length} = 7.958 \text{ ft.}$$

$$l_u/d = \frac{95.496}{11.25} = 8.49$$

$$l_e = 1.63l_u + 3d = 1.63(95.5) + 3(11.25) = 189.41 \text{ in.} = 15.78 \text{ ft.} \quad (\text{NDS Table 3.3.3})$$

$$R_b = \sqrt{\frac{l_e d}{b^2}} = \sqrt{\frac{189.41(11.25)}{(2 \times 1.5)^2}} = 15.39$$

$$R_b = 15.39 < 50 \quad ? \quad \mathbf{OK}$$

Euler-based ASD critical buckling value for bending members:

$$E_{\min y'} = E_{\min y}(C_M)(C_t)(C_i) = 580000(1)(1)(1) = 580000 \text{ psi}$$

$$F_{bE} = \frac{1.2E'_{\min y}}{(R_b)^2} = \frac{1.2(580000)}{(15.39)^2} = 2939.68 \text{ psi}$$

$$F_{bx}^* = F_{bx}(C_D)(C_M)(C_t)(C_F)(C_i)(C_r) = (900)(1.00)(1)(1)(1)(1)(1) = 900.00 \text{ psi}$$

Beam stability factor:

$$C_L = \frac{1 + F_{be}/F_{bx}^*}{1.9} - \sqrt{\left(\frac{1 + F_{be}/F_{bx}^*}{1.9}\right)^2 - \frac{F_{be}/F_{bx}^*}{0.95}} = \frac{1 + 2939.68/900.00}{1.9} - \sqrt{\left(\frac{1 + 2939.68/900.00}{1.9}\right)^2 - \frac{2939.68/900.00}{0.95}} = 0.979$$

$$F_{bx}' = (900)(1.00)(1)(1)(0.979)(1)(1)(1) = 881.1 \text{ psi}$$

2.) Shear:

Members subject to shear stresses shall be proportioned so that the actual shear stress parallel to grain or shear force at any cross section of the bending member shall not exceed the adjusted shear design value:

$$f_v \leq F_v' \quad (\text{NDS Sec. 3.4.1})$$

where:

$$f_v = \frac{3V}{2A}$$

$$F_v' = F_v(C_D)(C_M)(C_t)(C_i)$$

$$F_{vx}' = (180)(1.00)(1)(1)(1) = 180.00 \text{ psi}$$

Shear Reduction: Uniformly distributed loads within a distance, d, from supports equal to the depth of the bending member shall be permitted to be ignored. Concentrated loads within a distance equal to the depth of the bending member from supports shall be permitted to be multiplied by x/d where x is the distance from the beam support face to the load. See NDS 2015, Figure 3C.

$$f_v^* = \frac{3V^*}{2(N \times A)} = \frac{3(1934.44)}{2(2 \times 16.88)} = 85.98 \text{ psi}$$

$$f_v^* = 85.98 \text{ psi} < F_{vx}' = 180.00 \text{ psi} \quad (\text{CSI} = 0.48) \quad ? \quad \mathbf{OK}$$

No Reduction in Shear (conservative):

$$f_v = \frac{3V}{2(N \times A)} = \frac{3(2530.71)}{2(2 \times 16.88)} = 112.48 \text{ psi}$$

$$f_v = 112.48 \text{ psi} < F_{vx}' = 180.00 \text{ psi} \quad (\text{CSI} = 0.62) \quad ? \quad \mathbf{OK}$$

3.) Deflection:

Bending deflections calculated per standard method of engineering mechanics for live load and total load:

LL Allowable: L/360

TL Allowable: L/240

$$E_x' = E_x(C_M)(C_t)(C_i) = 1600000(1)(1)(1) = 1600000 \text{ psi}$$

$$\Delta_{LL} = \frac{5w_{LL}L^4}{384E_x'(N \times I_x)} = \frac{5(502)(7.958)^4}{384(1600000)(2 \times 177.98)} \times \left(12 \frac{\text{in.}}{\text{ft.}}\right)^3 = 0.08 \text{ in.}$$

$$(L/d)_{LL} = 95.50 / 0.08 = 1201$$

$$\Delta_{LL} = 0.08 \text{ in} = L/1201 < L/360 \quad ? \text{ OK}$$

$$\Delta_{TL} = \frac{5(w_{TL} + w_s)L^4}{384E_x'(N \times I_x)} = \frac{5(628 + 8.02)(7.958)^4}{384(1600000)(2 \times 177.98)} \times \left(12 \frac{\text{in.}}{\text{ft.}}\right)^3 = 0.10 \text{ in.}$$

$$(L/d)_{TL} = 95.50 / 0.10 = 948$$

$$\Delta_{TL} = 0.10 \text{ in} = L/948 < L/240 \quad ? \text{ OK}$$

4.) Bearing:

Members subject to bearing stresses perpendicular to the grain shall be proportioned so that the actual compressive stress perpendicular to grain shall be based on the net bearing area and shall not exceed the adjusted compression design value perpendicular to grain:

$$f_{c \perp} \leq F_{c \perp}' \quad (\text{NDS Sec. 3.10.2})$$

where:

$$f_{c \perp} = \frac{R}{A_b}$$

$$F_{c \perp}' = F_{c \perp}(C_M)(C_t)(C_i)$$

$$F_{c \perp x}' = (625)(1)(1)(1) = 625.00 \text{ psi}$$

$$A_b = b \times l_b = 1.5 \times 3.5 = 5.25 \text{ in}^2$$

$$f_{c \perp} = \frac{R}{N \times A_b} = \frac{2623.46}{2 \times 5.25} = 249.9 \text{ psi}$$

$$f_{c \perp} = 249.9 \text{ psi} < F_{c \perp x}' = 625.00 \text{ psi} \quad (\text{CSI} = 0.40) \quad ? \text{ OK}$$
