



Beam - Shear Diagram



Shear Reduction: Uniformly distributed loads within a distance, d, from supports equal to the depth of the bending member shall be permitted to be ignored. Concentrated loads within a distance equal to the depth of the bending member from supports shall be permitted to be multiplied by x/d where x is the distance from the beam support face to the load.
